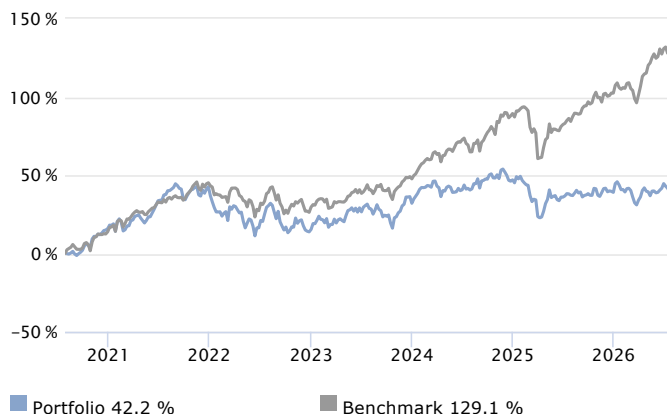
GROSS OF FEES IN EUR AS OF 31 JULY 2026

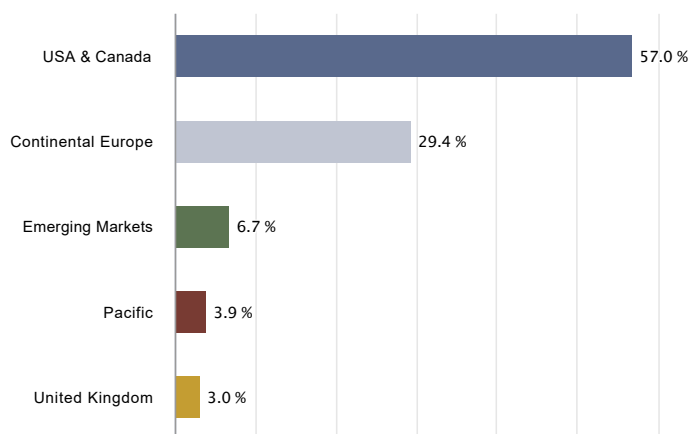
