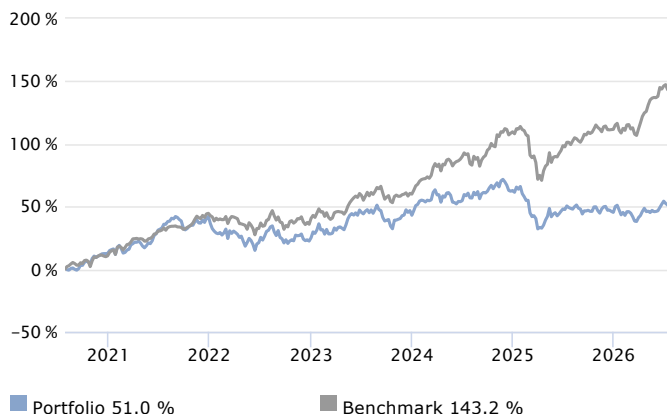
GROSS OF FEES IN SEK AS OF 31 JULY 2026

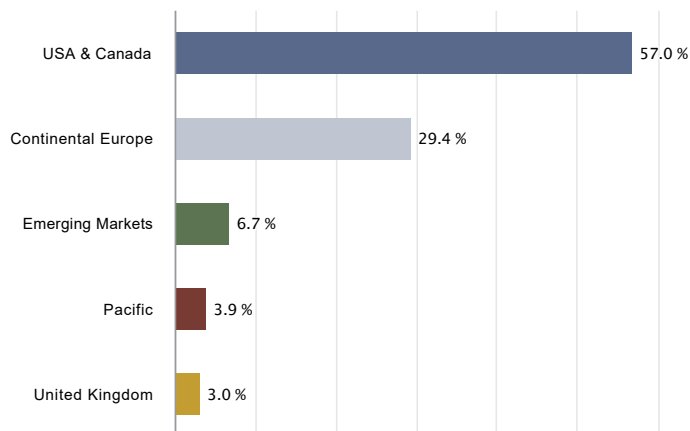
