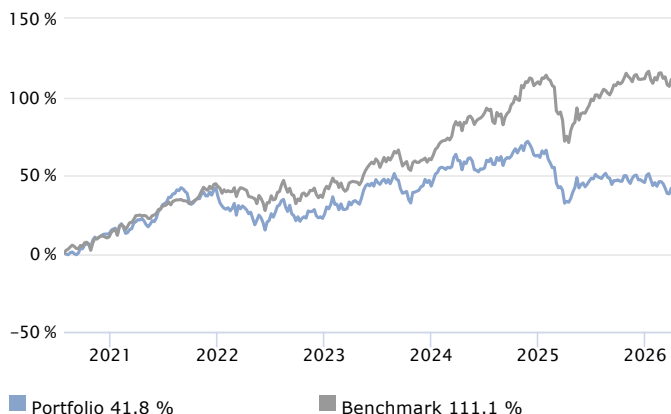
GROSS OF FEES IN SEK AS OF 31 MARCH 2026

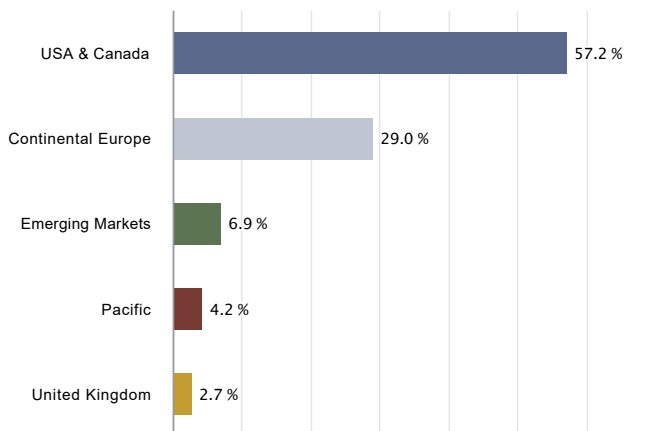
