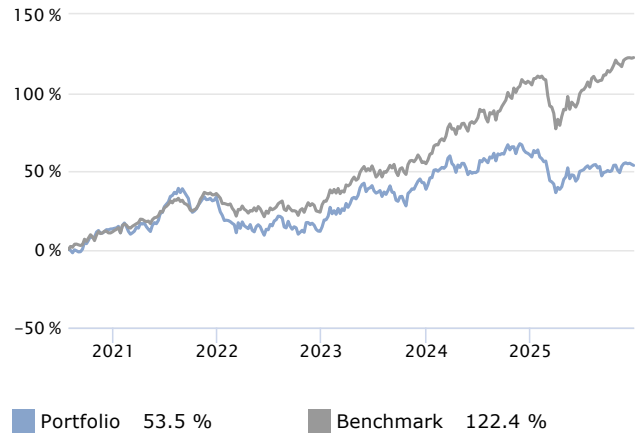
GROSS OF FEES IN NOK AS OF 31 DECEMBER 2025

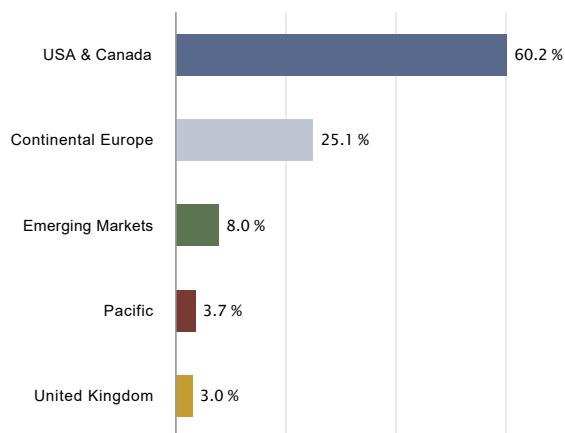
