C WORLDWIDE EMERGING MARKETS COMPOSITE

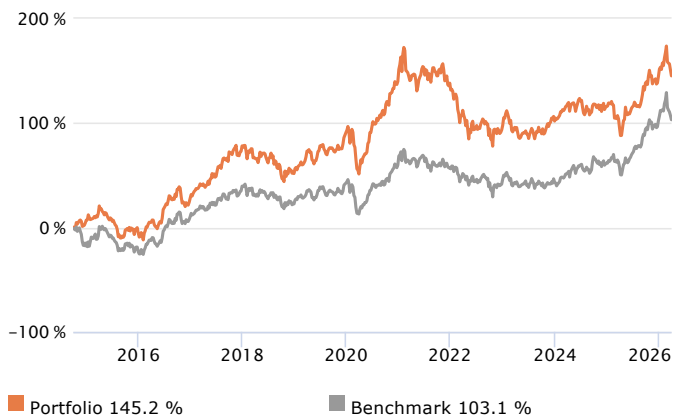
GROSS OF FEES IN GBP AS OF 31 MARCH 2026

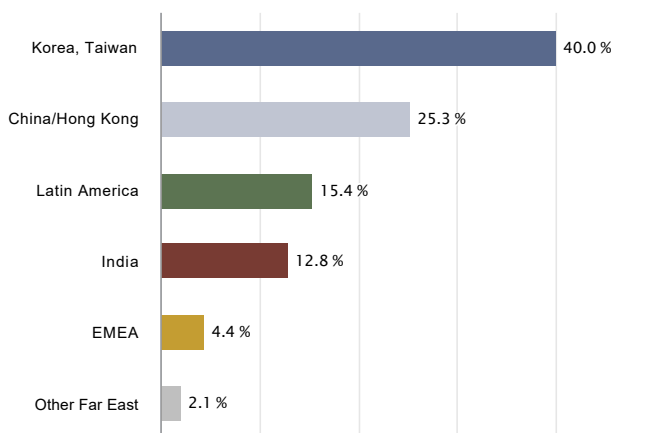
