C WORLDWIDE SWEDEN SMALL CAP COMPOSITE

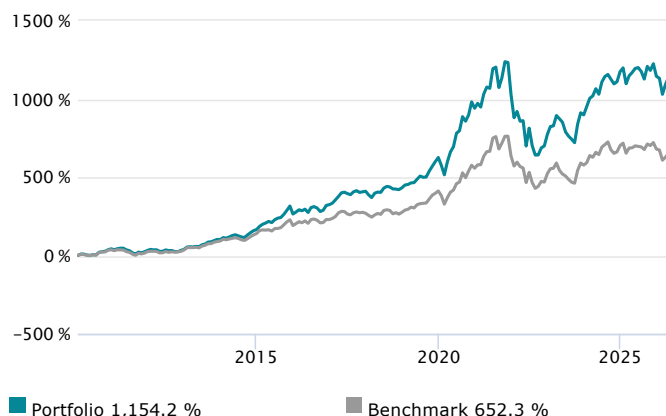
GROSS OF FEES IN NOK AS OF 31 JULY 2026

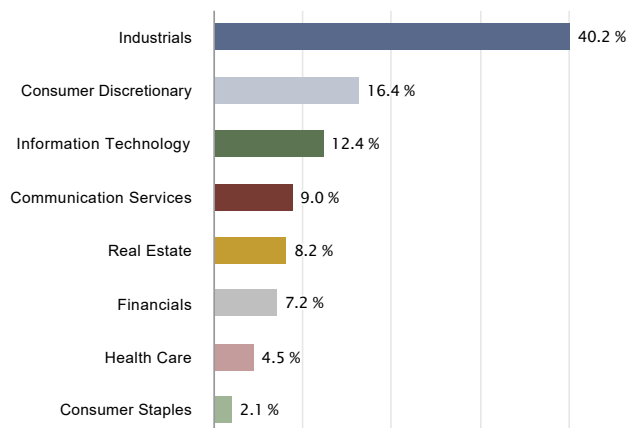
